# AFTER FIVE LIMOUSINES

This is a contract between the undersigned (CLIENT), and AFTER FIVE LIMOUSINES.

I, the undersigned (CLIENT), hereby AUTHORIZE AND AGREE, that "AFTER FIVE LIMOUSINES", will not be responsible or liable for personal articles left in the limousine(s) and assume full responsibility for myself and all guests during the rental period. Client agrees to pay a Non-refundable Deposit (between \$50.00 and \$100.00) in advance of each run. In addition to the Non-Refundable Deposit, the Client shall pay by Credit Card Hold the balance in full prior to the seven days of any run. If the Client cancels the run during the seven days preceding the run date, that entire amount paid shall be forfeited, the non-refundable deposit and the remaining run fee. The Client agrees to pay the bill in full in advance of each run in cash or credit card only, unless otherwise noted. Client must pay for at least the contracted number of hours stated at time of reservation booking. Client agrees to pay replacement value of all articles damaged, broken or missing from limousine(s). This includes any unusual cleaning costs. Client agrees there will be NO SMOKING in Limousine(s)! Damages will be advised then noted by driver. Client agrees to pay all costs incurred in the collection of the above expenses. Damages will be noted on front and/or back of the receipt.

Client must be over 18 years old and by signing below agrees to be liable for all damages to vehicle, and all fees and costs on behalf of any passengers including minors, even if Client is not a passenger his/herself.

The CLIENT signing this contract is responsible/liable for all charges if the person who contracted the run is unable to pay. In accordance to California State Law, persons under the age of 21 are not permitted to purchase or consume alcohol. In the event there is alcohol and or consumption of alcohol in our vehicles or use of illegal drugs, the run will be terminated and there will be no refund. Minors, anyone under 21 years of age, MAY NOT sign this contract.

The chauffeur and/or management of After Five Limousines reserves the right to terminate the service at any time if the client is in any way abusive to the chauffeur, highly intoxicated, participating in any illegal activities, or is placing anyone, including the car or driver in peril, and there will be no refund. After Five Limousines has the right, in the event of overbookings or mechanical failure, to "Farm Out" (offer a substitute limousine Company) to complete the run and will make every attempt to do so at the customers request.
